Ad-hoc chair for committee to discuss open floor topic from last month

From last month's minutes on open floor topic "Topic 3: Kevin – Policy – no longer requires group conscience to change policy. Would like this ASC body to show me where, if it did, got changed so that ASC body could change policy with 2/3 vote. Andrew – section 5 from May 2011 it says that "to later change, repeal, or add to the ASC guidelines requires a 2/3 majority vote of all voting GSRs/Proxies". Shellie – we need an ad-hoc committee to be formed (Kevin

agrees). Jennifer – groups are decision-makers and should go back to the groups. David – because we did vote on something last month, would we have to re-address this? Andrew – as of the last 3 years we have made changes to policy without going back to groups. Jan and Eric – GSRs need to come to ASC and report back to groups. "

There have been some attempts and literature chair has not been available. Literature chair is not available now to discuss it. Mike – does literature have a budget? Dave R – Ad-hoc at the beginning of the year to check on meetings to see if there was any way to help meetings. PI was involved. So the best we know these meetings are still happening.

OUR Leaders ARE BUT TRUSTED SERVANTS; THEY DO NOT GOVERN. #9 NA, as such, ought never be organized, but we may create service boards or committees DIRECTLY RESPONSIBLE TO THOSE THEY SERVE). <u>Concepts for NA service (#1</u> To fulfill our fellowship's primary purpose, the NA groups have joined together to create a structure which develops, coordinates, and maintains services on behalf of NA as a whole. #2 The final responsibility and authority for NA services rests with the NA groups. #3 The NA group delegate to the service structure the authority necessary to fulfil the responsibilities assigned to it. #5 For each responsibility assigned to the service structure, a single point of decisions and accountability should be clearly defined. #6 Group conscience is the spiritual means by which we invite a loving God to influence our decisions. #12 In keeping with the spiritual nature of Narcotics Anonymous, our structure should always be one of service, never of government).
