# Total Annual Budget amount submitted for approval: \$6,045.80

The 2013 budget was \$6,046.80 & actual 2013 expenses will be approx. \$1,300.00 under budget due to: Further reduction in need to provide printed copies of meeting lists to places requesting them. Also our printing was accomplished "In-house" by a Subcommittee member as opposed to using a "Vendor". Also expected increase in Toll Free AT&T minutes did not materialize.

Our 2014 budget is \$1.00 less than our 2013 amount. There are funds that were not spent in 2013 that we expect to use in either expanded or different areas during the 2014 year. The primary areas of this increase are; Printing costs are likely to rise sharply as we will be losing the "In-house" printing capabilities and will likely have to use a "Vendor" to fulfill our printing needs. Professional Outreach

presentations as well as costs will be increasing as we have determined that our presence at local seminars and educational events is both useful AND well received. Funds are included in case repainting (due to vandalism or weathering) of our current PSA at 2729 N 12<sup>th</sup> ST. is required.
